**Safety First: Rotherham Sailing Club has a safety record to be proud of. Members are expected to abide by the Club rules for their own safety and enjoyment and that of other Club members and its guests. In particular, all persons on the water must wear personal buoyancy aids. Some are available for hire free of charge from the club.**

**A patrol boat, crewed by two competent persons, must be on the water whenever sailing is taking place.**

**1. Participants/Members Legal Liabilities**

By signing the Membership form, applicants (and members) accept that:

- 1) They are entirely responsible for their own safety, their crew and their boats, whether afloat or ashore, and nothing done by the organiser reduces the participants of this responsibility.
- 2) It is for the boat to decide whether it is fit to sail in the conditions in which it will find itself. By launching the boat confirms that it is fit for those conditions and that its crew is competent to sail and compete in them.
- 3) The provision of the patrol boat does not relieve participants of their responsibilities.
- 4) Each and every boat is required to hold adequate insurance and in particular to hold insurance against third party claims in the sum of at least £2m.
- 5) Nothing done by the organisers will reduce the responsibility of the boat nor will it make the organisers responsible for any loss, damage, death or personal injury, however it may have occurred, as a result of the boat taking part in the racing. The organisers encompass everyone helping to run the race or any other event at the Club and include the trustees and committee the race management team, the race officer, patrol boat crew and any other person helping to run the event.
- 6) The Club shares information with a third-party for duty management processing which results in the publication of members names, no other personal information is published. A member who does not want his or her name to appear on the web may set his or her profile to anonymous from within the duty management software.

**2. Dependent Declaration: For parents or guardians of ALL children under 18, whether the child intends to sail or not:**

Parents and Guardians are warned that the Club is only able to provide patrol boat facilities during the hours of racing. Outside these hours, parents and guardians have sole responsibility for their children and wards, and must appreciate that the Club cannot be expected to exercise supervision or control.

**Even during racing, the Club cannot accept responsibility for children, or any other persons, not engaged in racing.**

Under law, children and wards are the Dependents of Parents and Guardians and in signing the Membership Form, Parents and Guardians accept this section and accept:

- 1) Children are their Dependents.
- 2) The section – Participants/Members Legal Liabilities – which excludes dependents’ right to claim compensation in certain circumstances.
- 3) Their dependent(s) competence to take part.
- 4) Their responsibility for their dependents during all racing series and other events.
- 5) That during the time their dependents are afloat, they will be in or around Rotherham Sailing Club, or they will inform the Race Officer and/or Safety Officer in writing, the name(s) of the person(s) acting in loco parentis during their absence. They will also inform the person(s) acting in loco parentis of any relevant medical condition suffered by the dependent.

### 3. Boat Declaration

By signing their Membership Form, participants confirm that their boat(s) will:

- 1) Hold a current measuring certificate, including a valid buoyancy endorsement and will do so for the whole sailing season, or
- 2) Be capable of floating for 30 minutes, while filled with water to the top of the centreboard case and with the usual crew and equipment on board, and
- 3) Have a securely tied painter that reaches at least 4m from the bow of the boat at all times, and
- 4) Hold adequate third party insurance in the sum of at least £2m at all times while in use at the Club; and
- 5) Be securely tied down, on land, to prevent possible damage to other craft during severe weather.
- 6) The Club accepts no responsibility for personal property and/or equipment.

### 4. Boat Berths

Please only use your allocated berth, if you should change/swap your Berth please inform the Treasurer. Berths that are empty may have still been allocated to members/visitors and you are respectfully asked not to use an empty berth without prior agreement of the Berth Holder or the Treasurer.

A copy of the berth allocations will be posted on the Club notice board and updated from time-to-time.
